

TUITION SCHEDULE (PK-6)

Tuition is required for all students enrolled in St. Paul's Lutheran School. Tuition payments may be made in one payment by **July 3, 2019** or in TEN EQUAL payments due on the first day of each month beginning on August 1, 2019 and ending on May 1, 2020.

DISCOUNT: 10% off the entire year if paid in full in cash or check by **April 23, 2019** or 5% off the entire year if paid in full in cash or check by **July 3, 2019**.

PRESCHOOL: Preschool tuition is listed below; multiple child discounts do not apply.

Church Member Tuition Rates

PRESCHOOL: St. Paul's Church members must pay full tuition for children enrolled in the 3 & 4 year old programs. Preschool tuition is listed below; multiple child discounts do not apply.

KINDERGARTEN - 6TH GRADE: The tuition rate for St. Paul's Church Members is approximately 50% of the non-member rate. These payments are to be made in the school office. St. Paul's Church budget pays the remaining 50% of the member tuition to the school through its regular ministry offering programs.

LATE TUITION FEE: Tuition payments made after the 10th calendar day of each month will be assessed a \$20.00 late fee. This late fee is assessed monthly as long as an unpaid balance remains.

LATE LUNCH FEE: Lunch payments made after the 10th calendar day of each month will be assessed a \$20.00 late fee. This late fee is assessed monthly as long as an unpaid balance remains.

LATE UPFRONT FEE: A \$30.00 per month late fee is assessed for any outstanding balance in upfront fees recorded after the first day of each month beginning August 2.

TUITION ASSISTANCE: St. Paul's offers *TUITION* assistance to families on a "needs" basis. Families may apply for up to 40% of their total tuition. Forms are available in the school office. No assistance can be given for PK3/4 children.
